Attendance at this training does not guarantee approval of your application but provides you with the tools you need to prepare for the application and interview process.

This program presents an essential analysis and in-depth discussion of the many components inherent in Category V parenting coordination. The training focuses on parenting coordination in Massachusetts, Standing Order 1-17, and frequently asked questions about Category V training. Practice tips are offered by parenting coordination experts.
